Our Privacy Policy statement

Your privacy is important to BambersInclusive C.I.Cand unless required to do so by law, we will never disclose, share, or sell your personal information without your consent. Data protection principles

- Kept no longer than is necessary.
- Processed and stored in a secure and confidential manner.

What data we collect and why

 We collect information in order to communicate with you, such as your name, postal/residential address, email address and telephone number. We also collect information such as date of birth and level of ability of a swimmer, any disability or SEND needs, and we record each swimmer's progress and achievements termly.

Under the GDPR, the lawful basis we rely on for processing this information is us having a legitimate interest.

- We also have to keep record of any specific medical conditions you tell us about that are relevant to the provision of safe and effective swimming lessons.
 - Under the GDPR, we rely on **your consent** for processing the special category data such as medical conditions.
- By accepting and agreeing to our Privacy Policy, **you consent** to your personal and special category data being processed as described above.

How we keep your data safe and comply with the GDPR
